The Council of Graduate Studies met at 3:30 p.m. on Thursday, April 16, 2015 in the President's Conference Room. Dr. Brenda Koerner called the meeting to order.

Action

- Minutes from the February 19, 2015 meeting were unanimously approved.
- Brian Schrader was unanimously elected to serve as Vice Chair for the 2015-2016 Graduate Council.

Reports/Discussion

- Council members discussed course term limits and course transfers for licensure programs. At present there is no time limits for the courses used in licensure programs, degree programs have a 7 year limit on courses that can be used in a degree program. No guiding policy for licensure courses, only for degree plans. It was suggested by Brian Schrader that the Deans be made aware that 10 years plus courses are being used for licensure programs. Council members will discuss this issue with their respective departments and this would be an item at the September meeting.
- Council members discussed the issues regarding The Boylan Scholarship criteria for distance students. Council members was concerned certain criteria was not comparable for the distance students. After council discussion, it was decided to discuss this issue with the foundation if criteria wording can be replaced.
- Council members discussed the shared credit hours for dual programs proposal. Council members will discuss the issue with their respective departments and this will be an agenda item at the September meeting.
- Brenda Koerner discussed the issues of the modifications of English proficiency testing and placement requirements for international students. Council members accepted the addendum that was added for the international students to validate IEP courses. The faculty senate will review this bill at the next senate meeting.












LAS Degree Seeking Total




School of Business Degree Total








The Council of Graduate Studies met at 3:30 p.m. on Thursday, October 29, 2015 in the President's Conference Room. Dr. Jerald Liss called the meeting to order.

Action

- Minutes from the September 17, 2015 meeting were unanimously approved.
- Elaine Henrie and Gonzalo Bruce discussed the full time graduate status from 6 credit hours to 9 hours. After discussion, graduate council members requested that Dr. David Cordle be invited to attend a graduate council meeting to discuss this issue with council members.
- Discussion occurred on the time limit and GPA for certificates. After council discussion, it
 was unanimously approved that the time limit and GPA will be the same guidelines as
 graduate degrees.
- Policy on Shared Hours for Dual Degree program was discussed and approved by council.
 See attached policy.

Reports/Discussion

- Council members discussed the process of advising by various departments. After council
 discussion, Dr. Ermler stated she would discuss the outcome with the faculty member who
 inquired.
- After discussion on the overall 3.0 GPA to obtain graduate degree, council members agreed to discuss the issues with their respective departments and advisors.
- Council members discussed the necessity of requesting all undergraduate transcripts, or last 60 credit hours with a 2.5 GPA. Council members agreed to take this issue back to their respective departments.

- Dr. Ermler discussed the rights of students and faculty, pertaining graduate faculty and selection of chair of thesis or committee members for thesis.
- Council members discussed the faculty eligible to vote for regular graduate faculty members. Council members unanimously agreed to leave the voting left to each respective department's level.
- Council members discussed the document on students denied to a program, coming back as non-degree students. Dr. Chad Wiley requested an amendment to include the following edit in bold:
 - Applicants who have been denied admission to a graduate program are not eligible for non-degree study during the academic semester after having been denied admission, except with permission of department.
 - This item was tabled, council members will discuss with their respective departments, will be an item on the next agenda.
- After discussion on the minimum number of credit hours required for Thesis, Dr. Liss recommended a minimum of 3 credit hours, council members unanimously approved.

Additional Information on Non-Degree Students – For Discussion at Graduate Council 10/29/15

Non-degree/Licensure Seeking Student Students with at least a baccalaureate degree from a regionally accredited institution who desire to enroll in graduate course work but are not seeking a degree or certificate are classified as non-degree or licensure students. Non-degree enrollment status is designed for students who wish to take courses but do not plan to pursue a degree. **Non-degree student do not qualify for financial aid.** Enrollment as a non-degree student does not guarantee admission to the University as a degree-seeking student. Non-degree seeking students are not exempt from any course prerequisites.

Students are required to pay a \$25 application fee and submit proof of baccalaureate degree (copy of unofficial transcript,) from a regionally accredited institution by the end of the first semester. Course term limits and transfer courses for licensure programs are to be decided by the respective departments. Faculty reserve the right to decide on the applicability of course work taken prior to formal admission into a degree program.

A non-degree or licensure student, who wishes to enter a degree program at a later date, must submit a new application and go through the admission review process. A maximum of 12 approved hours earned under this status may be applied to a degree program. All course work transferred from non-degree to degree seeking must be at B- or better. Students should check the graduate degree listing or contact the Teacher Licensure Coordinator in the Teachers College (620-341-5412) for specific licensure programs offered at ESU. Some departments do require official transcripts from licensure applicants.

Non-degree graduate students must maintain a 3.0 GPA. If the cumulative GPA is less than 3.0, the student will be given one automatic probationary semester. If the student fails to improve following the probationary semester, the student will be made ineligible to enroll as a non-degree or degree-seeking graduate student. If at any time a student's term or cumulative GPA falls below 2.0, the student will be ineligible to enroll as a non-degree graduate student.

To be added to admission requirements of degree seeking students.

Applicants who have been denied admission to a graduate program are not eligible for non-degree study during the academic year after having been denied admission.

Part of the following requirement list

- A bachelor's from a regionally accredited institution. Verification of undergraduate degree completion (Unofficial Transcript) must be sent to the Graduate School before an application can be processed. The document can be upload through the Graduate Application Portal, faxed to 620-341-5909, emailed to gradinfo@emporia.edu or mailed to: Emporia State University, Campus Box 4003, 1 Kellogg Circle, Emporia KS 66801.
- 2. Adequate preparation in the proposed area of specialization (to be determined by the department of specialization).
- 3. A grade point average of not less than 2.5 in the last 60 semester hours of study or an overall grade point average of no less than 3.0 for a completed master's degree. This admission does not constitute admission to a specific program.

- 4. Probationary* admission to the Graduate School is permitted if the student has a grade point average between 2.2 and 2.49 on the last 60 hours of study. However it is up to the department to admit a student on probation. The student must achieve a 3.00 grade point average in his or her first nine semester hours of graduate study. If the student does not meet this condition, she or he will not be permitted to continue in graduate study.
- 5. Applicants who have been denied admission to a graduate degree program are not eligible for non-degree study during the academic semester after having been denied admission.
- 6. Satisfactory completion of the entrance/admission tests required by the major department. Students who have not completed the required entrance/admissions tests by the first semester will not be allowed to enroll for a second semester. An enrollment hold will be placed on the student's account. Specific information about these examinations may be obtained from the department in which one wishes to study or from the Graduate School.
- 7. Submission of official transcripts from each institution attended. Transcripts are considered official only if they are received from the institution in a sealed envelope or are received through a secure transcript service. Official transcripts from a regionally accredited institution must be received by the end of the first semester or students will not be allowed to enroll in a second semester. Secure electronic transcripts are accepted if sent to gradinfo@emporia.edu directly from the issuing institution.
- 8. Students who have obtained a degree from a foreign university/college must have a transcript evaluation from a recommended external source that is a member of NACES (National Association of Credential Evaluation Services). Students will not be allowed to enroll until the evaluation has been received in the Graduate School.
- 9. Payment of a non-refundable \$40 application fee.

Graduate Council Updates

Happy Holidays to everyone. It is hard to believe that fall semester is almost over and that fall commencement is next weekend! Graduate Council met on Nov. 17 and made some changes to graduate policy that need to be shared with all graduate faculty. If you have questions related to these changes, please see your graduate council representative or contact me.

Actions taken by Graduate Council

- 1. At the current time, graduate students only need to have a 3.0 GPA in the courses listed on their degree plan to be awarded a degree; not an overall GPA of 3.0. Graduate Council voted to require that graduate students must have a 3.0 overall and a 3.0 GPA in degree plan in order to be awarded a degree.
- 2. At the current time, the graduate school requires all undergraduate transcripts to be sent to the graduate office before lifting hold on student. Since the graduate admission requires a 2.5 GPA in the last 60 hours, the discussion focused on the necessity of requesting all undergraduate transcripts. Council approved the change to request official transcripts from where undergraduate degree was conferred and if the student has at least 60 hours from that university, no further transcripts will be requested. Departments may request additional transcripts if necessary.
- 3. At the current time, a student who applies to a degree program and is denied, can reapply as a non-degree student and begin to take classes. Council members approved the process for applicants who have been denied admission to a graduate program are not eligible for non-degree study during the academic semester after having been denied admission to the degree program; except with permission of the department. Essentially, we are requiring students who have been denied to an academic program to wait 1 semester before coming back as a non-degree student. This does not mean the student cannot reapply to another graduate degree immediately.

Discussion items currently being considered by Council

- 1. Graduate Assistants splitting the award in half .5 award Information on the possibility of splitting an award is being explored and will be shared at the next council meeting
- 2. Shared hours and transfer hours. Council is looking at the way in which transfer hours can be shared with 2 degrees.

Draft statement about transfer hours being shared with 2 degree programs

Emporia State Graduate School policy on transfer credits states:

No more than nine (9) semester hours of credit may be transferred into an ESU program requiring fewer than 40 hours of graduate coursework, or fifteen (15) into an ESU program requiring 40 or more hours of graduate coursework. Individual programs may reduce this limit at their discretion.

In cases where graduate students are entering two graduate programs, the accepted number of transfer hours may be applied to one of the two degree programs or divided between the two degree programs. The accepted number of transfer credit cannot be applied to each degree program separately.

Additional Information on Non-Degree Students – For Discussion at Graduate Council 10/29/15

Non-degree/Licensure Seeking Student Students with at least a baccalaureate degree from a regionally accredited institution who desire to enroll in graduate course work but are not seeking a degree or certificate are classified as non-degree or licensure students. Non-degree enrollment status is designed for students who wish to take courses but do not plan to pursue a degree. **Non-degree student do not qualify for financial aid.** Enrollment as a non-degree student does not guarantee admission to the University as a degree-seeking student. Non-degree seeking students are not exempt from any course prerequisites.

Students are required to pay a \$25 application fee and submit proof of baccalaureate degree (copy of unofficial transcript,) from a regionally accredited institution by the end of the first semester. Course term limits and transfer courses for licensure programs are to be decided by the respective departments. Faculty reserve the right to decide on the applicability of course work taken prior to formal admission into a degree program.

A non-degree or licensure student, who wishes to enter a degree program at a later date, must submit a new application and go through the admission review process. A maximum of 12 approved hours earned under this status may be applied to a degree program. All course work transferred from non-degree to degree seeking must be at B- or better. Students should check the graduate degree listing or contact the Teacher Licensure Coordinator in the Teachers College (620-341-5412) for specific licensure programs offered at ESU. Some departments do require official transcripts from licensure applicants.

Non-degree graduate students must maintain a 3.0 GPA. If the cumulative GPA is less than 3.0, the student will be given one automatic probationary semester. If the student fails to improve following the probationary semester, the student will be made ineligible to enroll as a non-degree or degree-seeking graduate student. If at any time a student's term or cumulative GPA falls below 2.0, the student will be ineligible to enroll as a non-degree graduate student.

To be added to admission requirements of degree seeking students.

Applicants who have been denied admission to a graduate program are not eligible for non-degree study during the academic semester after having been denied admission, except with permission of department.

Part of the following requirement list

- A bachelor's from a regionally accredited institution. Verification of undergraduate degree completion (Unofficial Transcript) must be sent to the Graduate School before an application can be processed. The document can be upload through the Graduate Application Portal, faxed to 620-341-5909, emailed to gradinfo@emporia.edu or mailed to: Emporia State University, Campus Box 4003, 1 Kellogg Circle, Emporia KS 66801.
- 2. Adequate preparation in the proposed area of specialization (to be determined by the department of specialization).

- 3. A grade point average of not less than 2.5 in the last 60 semester hours of study or an overall grade point average of no less than 3.0 for a completed master's degree. This admission does not constitute admission to a specific program.
- 4. Probationary* admission to the Graduate School is permitted if the student has a grade point average between 2.2 and 2.49 on the last 60 hours of study. However it is up to the department to admit a student on probation. The student must achieve a 3.00 grade point average in his or her first nine semester hours of graduate study. If the student does not meet this condition, she or he will not be permitted to continue in graduate study.
- Applicants who have been denied admission to a graduate degree program are not eligible for non-degree study during the academic semester after having been denied admission, except with permission of department.
- 6. Satisfactory completion of the entrance/admission tests required by the major department. Students who have not completed the required entrance/admissions tests by the first semester will not be allowed to enroll for a second semester. An enrollment hold will be placed on the student's account. Specific information about these examinations may be obtained from the department in which one wishes to study or from the Graduate School.
- 7. Submission of official transcripts from each institution attended. Transcripts are considered official only if they are received from the institution in a sealed envelope or are received through a secure transcript service. Official transcripts from a regionally accredited institution must be received by the end of the first semester or students will not be allowed to enroll in a second semester. Secure electronic transcripts are accepted if sent to gradinfo@emporia.edu directly from the issuing institution.
- 8. Students who have obtained a degree from a foreign university/college must have a transcript evaluation from a recommended external source that is a member of NACES (National Association of Credential Evaluation Services). Students will not be allowed to enroll until the evaluation has been received in the Graduate School.
- 9. Payment of a non-refundable \$40 application fee.

Additional Information on Non-Degree Students – For Discussion at Graduate Council 10/29/15

Non-degree/Licensure Seeking Student Students with at least a baccalaureate degree from a regionally accredited institution who desire to enroll in graduate course work but are not seeking a degree or certificate are classified as non-degree or licensure students. Non-degree enrollment status is designed for students who wish to take courses but do not plan to pursue a degree. Non-degree student do not qualify for financial aid. Enrollment as a non-degree student does not guarantee admission to the University as a degree-seeking student. Non-degree seeking students are not exempt from any course prerequisites.

Students are required to pay a \$25 application fee and submit proof of baccalaureate degree (copy of unofficial transcript,) from a regionally accredited institution by the end of the first semester. Course term limits and transfer courses for licensure programs are to be decided by the respective departments. Faculty reserve the right to decide on the applicability of course work taken prior to formal admission into a degree program.

A non-degree or licensure student, who wishes to enter a degree program at a later date, must submit a new application and go through the admission review process. A maximum of 12 approved hours earned under this status may be applied to a degree program. All course work transferred from nondegree to degree seeking must be at B- or better. Students should check the graduate degree listing or contact the Teacher Licensure Coordinator in the Teachers College (620-341-5412) for specific licensure programs offered at ESU. Some departments do require official transcripts from licensure applicants.

Non-degree graduate students must maintain a 3.0 GPA. If the cumulative GPA is less than 3.0, the student will be given one automatic probationary semester. If the student fails to improve following the probationary semester, the student will be made ineligible to enroll as a non-degree or degree-seeking graduate student. If at any time a student's term or cumulative GPA falls below 2.0, the student will be ineligible to enroll as a non-degree graduate student.

Applicants who have been denied admission to a graduate program are not eligible for non-degree Part of the following requirement list

Part of the following requirement list

- 1. A bachelor's from a regionally accredited institution. Verification of undergraduate degree completion (Unofficial Transcript) must be sent to the Graduate School before an application can be processed. The document can be upload through the Graduate Application Portal, faxed to 620-341-5909, emailed to gradinfo@emporia.edu or mailed to: Emporia State University, Campus Box 4003, 1 Kellogg Circle, Emporia KS 66801.
- 2. Adequate preparation in the proposed area of specialization (to be determined by the department of specialization).
- 3. A grade point average of not less than 2.5 in the last 60 semester hours of study or an overall grade point average of no less than 3.0 for a completed master's degree. This admission does not constitute admission to a specific program.

- 4. Probationary* admission to the Graduate School is permitted if the student has a grade point average between 2.2 and 2.49 on the last 60 hours of study. However it is up to the department to admit a student on probation. The student must achieve a 3.00 grade point average in his or her first nine semester hours of graduate study. If the student does not meet this condition, she or he will not be permitted to continue in graduate study.
- 5. Applicants who have been denied admission to a graduate degree program are not eligible for non-degree study during the academic semester after having been denied admission.
- 6. Satisfactory completion of the entrance/admission tests required by the major department. Students who have not completed the required entrance/admissions tests by the first semester will not be allowed to enroll for a second semester. An enrollment hold will be placed on the student's account. Specific information about these examinations may be obtained from the department in which one wishes to study or from the Graduate School.
- 7. Submission of official transcripts from each institution attended. Transcripts are considered official only if they are received from the institution in a sealed envelope or are received through a secure transcript service. Official transcripts from a regionally accredited institution must be received by the end of the first semester or students will not be allowed to enroll in a second semester. Secure electronic transcripts are accepted if sent to gradinfo@emporia.edu directly from the issuing institution.
- 8. Students who have obtained a degree from a foreign university/college must have a transcript evaluation from a recommended external source that is a member of NACES (National Association of Credential Evaluation Services). Students will not be allowed to enroll until the evaluation has been received in the Graduate School.
- 9. Payment of a non-refundable \$40 application fee.

The Council of Graduate Studies met at 3:30 p.m. on Thursday, April 14th, 2016 in the President's Conference Room. Dr. Brian Schrader called the meeting to order.

Congratulations

• Graduate Council Committee congratulated and showed their appreciation to Dean Ermler for her time as the Dean of Graduate School and Distance Education.

Action

- Minutes from the February 18th meeting were unanimously approved.
- Mel Storm was unanimously elected to serve as Vice Chair for the 2016-2017 Graduate Council.

Reports/Discussion

- Council members discussed the probationary requirements and reasons for graduate study eligibility. Council members unanimously agreed that probationary conditions cannot extend more than 1 year or for a certain number of credit hours. The probationary requirements are required on the eligibility form. At the end of timeframe an automatic hold will be placed on students records.
- Council members discussed the draft policy related to academic standards for non-degree and degree seeking students. The Council members unanimously agreed with the policy change to go into effect Fall 2016. The policy reads, "Non-degree graduate students are held to the same academic standard as degree seeking graduate students. Degree seeking graduate students and non-degree graduate students must maintain a 3.0 GPA. If a graduate (Degree and Non-degree) student's semester GPA falls below 3.0, the student will be placed on academic probation and may be dismissed from her/his graduate program at the discretion of the department (denial of degree candidacy). A student who has two consecutive semesters of a GPA below a 3.0 will be dismissed from the Graduate School and not be permitted to enroll in classes. "

- Dean Ermler advised the council members the graduate student's degree plan will not be signed off with extra credit hours listed, only include the credit hours the graduate degree program requires.
- Council members discussed the number of transfer credit hours that will be accepted for a certificate program. After discussion council members agreed to take this issue back to their respective departments. This item will be on the September agenda.
- Council members discussed the advantages and disadvantages of splitting (½ time to ¼ time) the Graduate Assistantship stipend and tuition waivers. Council members unanimously agreed to make this an option for the graduate assistantships in their respective departments. Dean Ermler will bring this to Dr. Cordle for his approval before moving forward.

Good Morning

The Provost has approved the recommendation (passed by the Graduate Council) to permit departments the option to split Graduate Assistant position. A split GA is a graduate assistant:

- 1. Assigned ONLY 10 hours of work per week
- 2. Is not eligible for benefits or health insurance
- 3. Receives ½ of the full GA stipend
- 4. Receives only a 3 credit hour course waiver any credit hours taken above 3 hours are charged at the Kansas resident tuition and paid for by the graduate assistant.

If you are considering or will be splitting the GA positions assigned to you for next year, you **must contact Jan Gerstner** to discuss the process used to split and hire a 10 hour GA.
